AWM Financial Services, Inc. ("AWM" or "Firm") is registered with the Securities and Exchange Commission (SEC) as an investment adviser.

Brokerage and investment advisory services and fees differ, and it is important for you, our client, to understand the differences. WHAT INVESTMENT SERVICES AND ADVICE CAN YOU PROVIDE ME?

The principal services our firm offers include portfolio management, financial planning and consulting services and selection of other advisors to retail investors. Investment management services are provided on a discretionary basis, which means that we can make changes to your portfolio without first obtaining your express prior permission. We regularly monitor your investment accounts and make investment changes when necessary. Our firm accepts new clients with a minimum of \$500,000 of investable assets. We do not offer proprietary products or wrap fee programs.

When we manage your assets, we act as a fiduciary, which means that we must prudently take care of your money and must, at all times, act for your benefit.

WHAT FEES WILL I PAY?

Our Investment Management fees are based on a percentage of Assets under Management. Asset Management fees are paid monthly in arrears and debited from your account. Fees for Financial Planning and Consulting are hourly and negotiated with each individual client. AWM imposes an annual administrative and technology fee of \$50 on all accounts. This fee is typically debited at the end of the May billing cycle.

In addition to the fees we charge, you may also pay Transaction Fees and fees charged by individual Mutual Funds, Separate Account Managers or Variable Annuities.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

CONVERSATION STARTERS, ask your financial professional:

HELP ME UNDERSTAND HOW THESE FEES AND COSTS MIGHT AFFECT MY INVESTMENTS. IF I GIVE YOU \$10,000 TO INVEST, HOW MUCH WILL GO TO FEES AND COSTS, AND HOW MUCH WILL BE INVESTED FOR ME?

WHAT ARE YOUR LEGAL OBLIGATIONS TO ME WHEN ACTING AS MY INVESTMENT ADVISER? HOW ELSE DOES YOUR FIRM MAKE MONEY AND WHAT CONFLICTS OF INTEREST DO YOU HAVE?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates a conflict with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here is an example to help you understand what this means.

- Individuals providing investment advice on behalf of our firm are licensed as independent insurance agents. These individuals will earn commission-based compensation for selling insurance products. Insurance commissions are separate and in addition to our advisory fees. This practice presents a conflict of interest because they have an incentive to recommend insurance products to you which will generate commission.
- The Founder/CEO of AWM also owns a tax and business consulting practice, an IMO, and an insurance agency. This ownership interest may create a conflict of interest when recommending tax or insurance services. Clients are under no obligation to use the services of any firm we recommend, affiliated with or otherwise, and may obtain comparable services through any firm of their choice.

Our financial professionals are paid a percentage of the advisory fee we charge you after our expenses are paid, some receive a salary and some receive both.

This creates a conflict of interest as it incentivizes the financial professional to recommend that the client have more assets under our management. Our firm has a code of ethics which we abide by at all times that addresses this conflict and ensures financial professionals always act in the client's best interest.
